- No notices of violation were voluntarily complied with.


- 3 courtesy notices of violation from previous months compliance were achieved resulting in closure.

BUILDING



Revenues for Building related fees for **December** were **\$196,770.00**.




Active Building Permits 12/01/2024-12/31/2024




Walnut Street and Orange Avenue Intersection Traffic Volumes




Ferris Street and Orange Avenue Intersection Traffic Volumes
